3. ACQUIRED KNOWLEDGE, SKILLS AND PROFESSIONAL COMPETENCES

The holder of the certificate is qualified to:

- read, plan, elaborate, monitor and amend technical documentation in line with requisite instructions and by employing ICT;
- the use of organization of work concepts and economics in a professional area;
- programme simple applications on programmable devices as well as programme, assemble and wire programmable relays;
- set up necessary operating system settings and provide basic support to users when employing user software;
- compile, maintain, rectify errors and service computer hardware;
- lay and wire different forms of electric and communication installations, connect users and carry out basic maintenance works;
- connect electric installation elements in switching, distribution and outlet-coupling devices as well as select and connect electrical protection;
- set up, maintain, protect and provide the restoration of network services.

Optional:

- record, archive and reproduce sound, image and video in digital format;
- design preparation of photos and videos.
- advise on the use of e-certificates and signatures;
- protect IC systems against unauthorised access and dangerous programmes.
- set up and manage system and user software;
- cooperate with users, suppliers and customers.
- plan the development of simple computer programmes;
- make and test small parts in big programmes.
- archive and restore databases, launch complex searches;
- draw up server procedures and triggers for applying business rules and dealing with exceptions.
- use digital photo capture devices;
- design web sites and other documents for the electronic media.

In addition, the holder of the certificate also upgraded his/her key professional skills and competences with key general knowledge and skills in line with national standards.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO HOLDER OF THE CERTIFICATE

The holder of the certificate can find employment at areas pertaining to the setting up and maintenance of local computer networks and connections through public networks namely training participants with elective modules in communication systems; areas pertaining to the setting up and maintenance of IT systems namely training participants with elective modules in communication systems; areas pertaining to computer programme planning and design namely training participants with elective modules in programming; web site design namely training participants with elective modules in computer design.

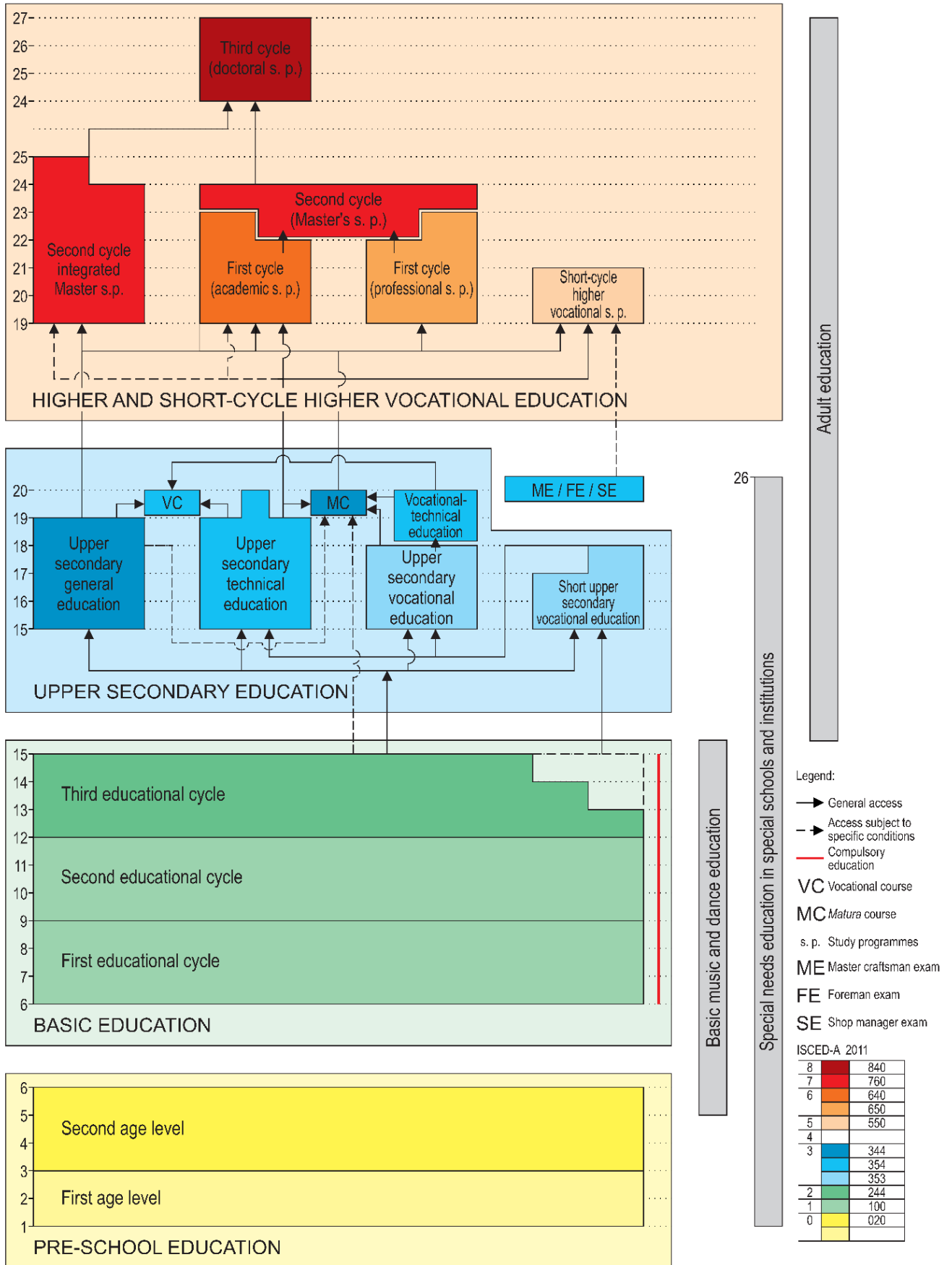
